

Altura Credit Union “2021 Swipe to Win Giveaway”

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. Each individual entry has an equal chance of winning. THE FOLLOWING SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS OF THE U.S. ONLY, WHO MEET THE ELIGIBILITY REQUIREMENTS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED.

Odds: Winner selected by random drawing. Odds of being selected as the winner depend on number of entries.

Promotion Period: Sweepstakes registration is scheduled to begin on **1/13/21 and ends 12/31/21** (the “Registration Period”). Three winners will be awarded each week and starting the week of 3/29/2021. Additional quarterly winners will be awarded starting the week of 3/29/2021 and for each remaining quarter in 2021, as well as annual winners after 12/31/2021. The sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

Who May Enter: The sweepstakes is open to legal residents of the 50 United States and District of Columbia (“D.C.”), who reside within 250 miles of a participating Altura Credit Union location (see below), who are age 18 or older as of date of entry with a valid driver’s license. The following are not eligible to enter:

- Employees, officers, and directors of Altura Credit Union (“Credit Union”), each of their respective franchisees, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this promotion (collectively, “Released Parties”) and the members of the immediate families or households of any of the above, whether or not related. “Immediate family members” includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grand children (including step grandchildren) and each of their respective spouses.

How to Enter

- Consumers who use their Altura Debit or Credit Card during the time of registration will be automatically entered 1 times.
- All other persons may enter by completing a write-in entry form, a maximum of one time. Legibly print name, address (including zip code), telephone number (including area code), and e-mail address (optional) on a 3" x 5" card and by sending it in a #10 stamped envelope to:

Proof of mailing does not constitute proof of delivery. The Credit Union is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries or mail. Once submitted, entries become the sole property of the Credit Union and will not be acknowledged or returned.

All mailed entries must be handwritten. All such entries will be automatically void. All entries received become the property of the Sponsor and will not be returned. Difficulties with phone lines or getting to locations to enter the Sweepstakes are not the responsibility of Sponsor.

Winner Selection:

Random drawings will be held to select three winners each week starting the week of 3/29/2021. Winners will be notified by phone no later than the Wednesday of each week for the prior week's entries. Additional winners will be selected each quarter (January - March, April - June, July - September, October - December) and after 12/31/2021 and will be notified within one week if they have won. Any selected entrant that cannot be reached within 72 hours, to confirm he/she has been selected as a winner, after an initial phone call to the number listed on his/her account or entry, or who does not meet the eligibility requirements, will be disqualified. An alternate winner will then be randomly selected and notified per the procedures outlined above, time permitting.

Maximum of one winner may be selected per household, regardless of qualification method. Only the eligible winner as selected and notified by Sponsor will be eligible to participate in the presentation event. All other entrants are ineligible. No one may qualify or participate on behalf of another individual. Decisions of the Sweepstakes Administrator in the selection and designation of winner and all matters relating to this Sweepstakes are final.
